For the benefit of millions of people who are not fully aware of the abuse and abuse of the leaders of the homosexual organization called LGBTI, I summarize the case that is supposed to be brought to trial this **October 15, 2019**.

Summary of Stephanie Hayden's case against Kate Scottow

Who is Stephanie Hayden? He was born male, man, manlike, under the name of Anthony George Steven Halliday, then changed to want to be a woman under the name of Stephanie Hayden. She is a specialist in lawsuits, in making contentious lawsuits against anyone who goes against the doctrines and actions of the LGBTI

organization or people who have this condition. In addition, and I quote from HasteOir.org: *“he has a criminal record for physical aggression, various crimes of fraud and sexual assault. He began attacking Caroline through social networks in a relentless campaign of harassment, even attacking and insulting his Christian faith.”*

Who is Kate Scottow? She is a journalist of the citizengo.org religious organization, an organization that supports justice against abuse, corruption and all kinds of crimes that may remain in impunity. Kate Scottow is a British citizen, married and with five children.

 **The summary of the development of this story**, according to hundreds of publications, both religious and journalistic, is as follows:

A British mother was reportedly arrested and jailed for referring to a transgender woman as a man via the Internet.

Kate Scottow said the police arrived at her home, took her to the local police station for questioning and left her in a cell for seven hours while her children watched, according to reports from a British media.

Scottow had been involved in a Twitter dispute with a transgender activist about "deadnaming," that is, denying the gender that someone thinks he really is.

Scottow talked about his terrible experience at an online forum in the UK called Mumsnet. She said she is also prohibited from referring to transgender Stephanie Hayden as a man through a court order initiated by Hayden.

Stephanie Hayden, formerly Anthony George Steven Halliday, asks for a fine of 150,000 euros and imprisonment to the director of CitizenGO campaigns in the United Kingdom. The plaintiff is a well-known UK transgender activist specializing in lawsuits under the LGBTI Equality Act.

The origin of this investigation is that Farrow, in the exercise of freedom of thought and expression, assured that the so-called "sex reassignment" of a child under 16 years old was actually a case of "castration", a "mutilation" and a "child abuse."

The case Farrow was referring to is the son of a well-known trans activist Susie Green, whose son he was going to take to Thailand to carry out the surgical transformation. The controversy that was generated in the United Kingdom reached the Asian country, in such a way that it adopted the decision to prohibit this type of interventions until the age of 18, as it happens in the European island.

Farrow then became the center of a wave of criticism and harassed actions orchestrated from LGTBI pressure groups, despite which the police abandoned the case, understanding that freedom of expression protected Farrow's words.

My total conviction, evidence and opinion in this case and others similar

The rotten and malignant surface of Stephanie Hayden, before Anthony George Steven Halliday, emerges and sprouts from the surface on the earth, like an erupting volcano, and not only of this person, but of the LGBTI organization.

And even as they did not like to retain God in their knowledge, God gave them over to a reprobate mind, to do those things which are not convenient; Being filled with all unrighteousness, fornication, wickedness, covetousness, maliciousness; full of envy, murder, debate, deceit, malignity; whisperers, Backbiters, haters of God, despiteful, proud, boasters, inventors of evil things, disobedient to parents,

Without understanding, covenantbreakers, without natural affection, implacable, unmerciful: Who knowing the judgment of God, that they which commit such things are worthy of death, not only do the same, but have pleasure in them that do them.

If we look closely at the behavior of the leaders of this LGBTI organization, the apostle Paul is as if he were directly mentioning all those whom I am naming in this document.

Therefore, this is a wise conclusion, attached to the truth without offense or lawsuit, but the truth, let's see:
